- (ii) The individual set of items will be sold to the highest bidder.
- (iii) The selected bidder will be required to deposit the quoted amount in bank account of this High Commission. Selected bidder may arrange the pick-up of items only after confirmation of the receipt of the fund in HCI, Account. Once, receipt of fund is confirmed, the bidder should collect the items within three-days after confirmation of receipt of the fund.
- (iv) Goods are sold on the assumption that the bidder will have to take delivery of the goods not withstanding all the faults and flaws, if any, in the condition or description etc. of goods irrespective of whether it was actually inspected or not.
