In addition, these partnerships promote innovation, ensure efficient resource allocation, and build resilient water systems that can withstand evolving challenges, ultimately fostering long-term socio-economic and environmental well-being, forging a path towards a future where water development is not only sustainable but inclusive.

It is in this context that the Department of Water Resources, River Development and Ganga Rejuvenation, Ministry of Jal Shakti is organising the 8<sup>th</sup> India Water Week 2024 to emphasise **"Partnerships and Cooperation for Inclusive Water Development and Management."**



## What is India Water Week

The Ministry of Jal Shakti, Government of India, conceptualised and organised India Water Week in 2012, and it has since grown into a significant event. Designed as a 5-day conference and exhibition, it stands as India's premier international water resources gathering. Since its inception, the event has been a testament to the government's commitment to addressing water-related challenges on a global scale.

## Partnering Organisations

IWW-2024 will be organised by the Department of Water Resources, River Development and Ganga Rejuvenation, Ministry of Jal Shakti. It will collaborate with various partners, including nodal ministries and departments like the Department of Drinking Water and Sanitation, the Ministry of Environment, Forest and Climate Change, the Ministry of Power, the Ministry of Agriculture and Farmers' Welfare, the Ministry of Earth

Sciences, the Ministry of Housing and Urban Affairs, NITI Ayog and the Ministry of Rural Development. State government departments, expert organisations, international bodies, and private and public business groups will also be a part of this collaborative effort.

The 8<sup>th</sup> India Water Week-2024 is being organised by the Ministry of Jal Shakti and is scheduled to take place from September 17 - 21, 2024.





## 8<sup>th</sup> India Water Week-2024

This event will function as an international forum, facilitating the exchange of perspectives and knowledge among distinguished politicians, stakeholders, scholars, planners, and innovators, as well as esteemed decision-makers in the field of water resources across the globe. The focal point of this 5-day event will be "**Partnerships and Cooperation for Inclusive Water Development and Management.**"
